- 4.3 System shall not be installed at slopes less than 3-½":12".

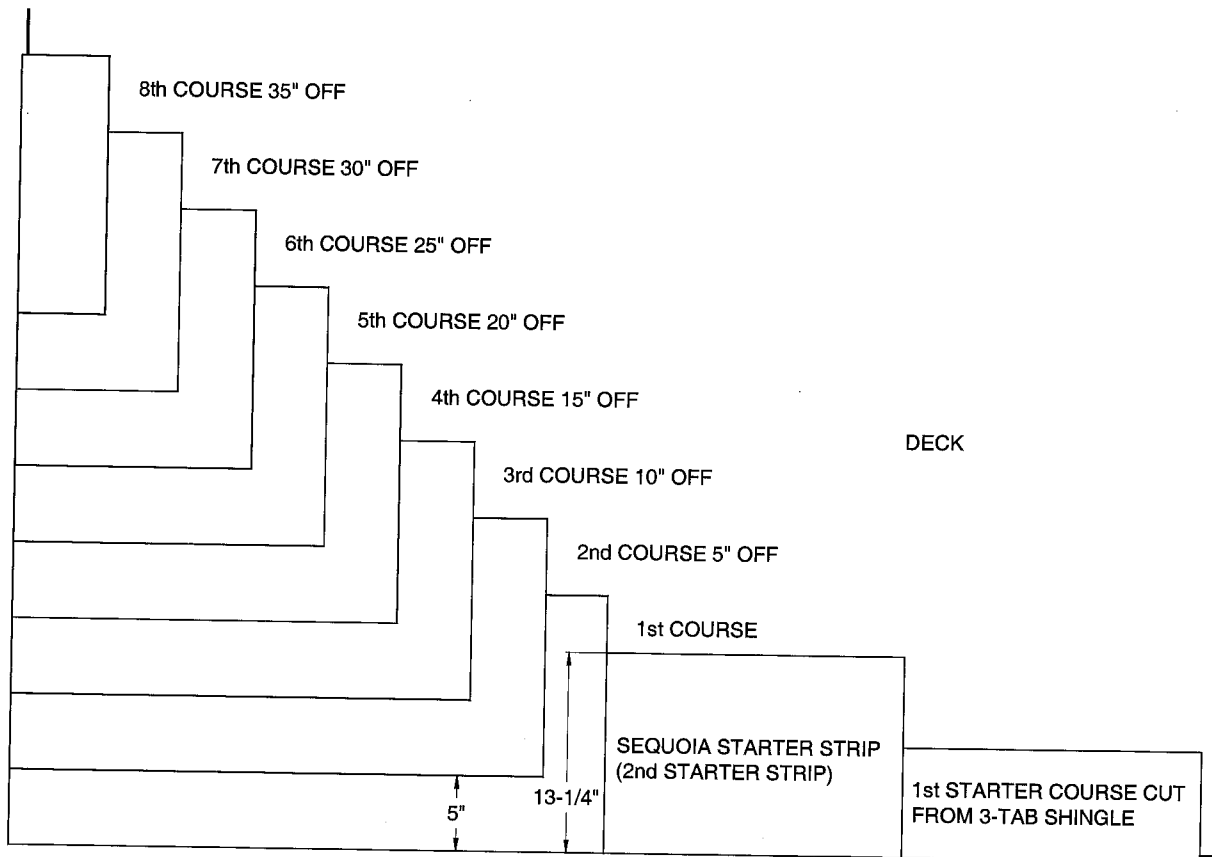

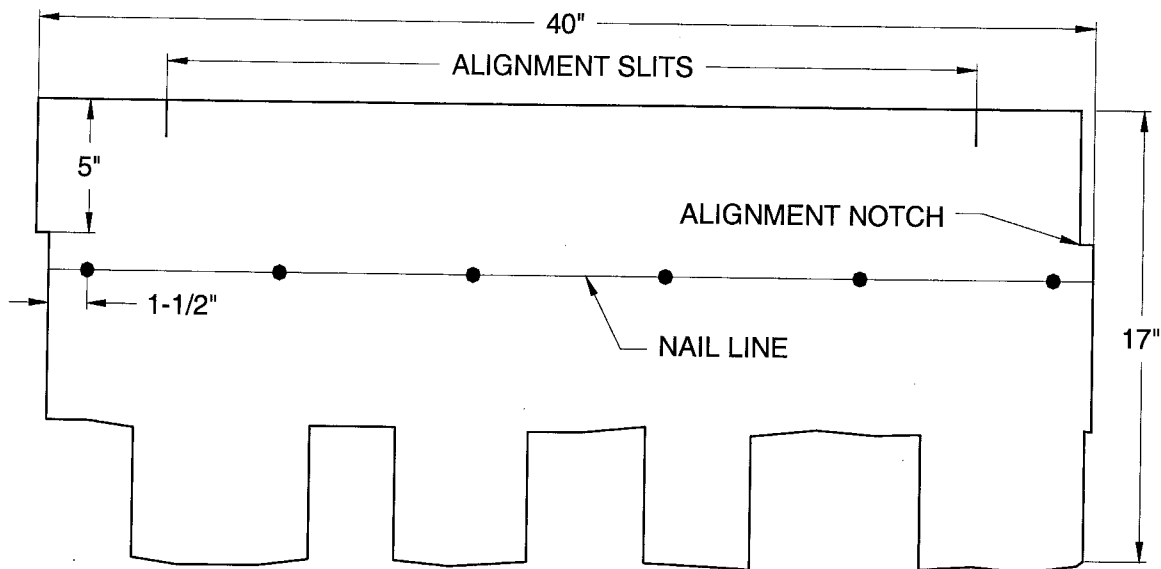

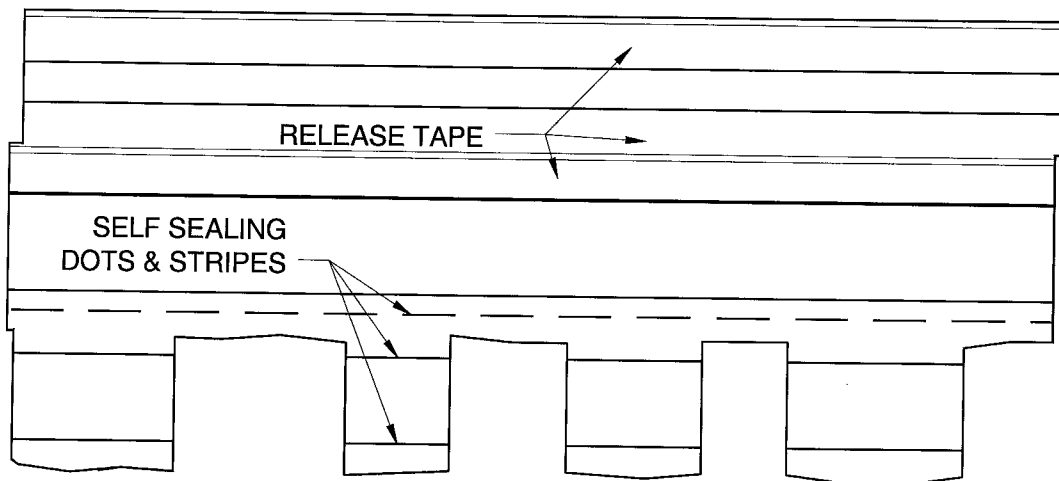
**DETAIL A**
