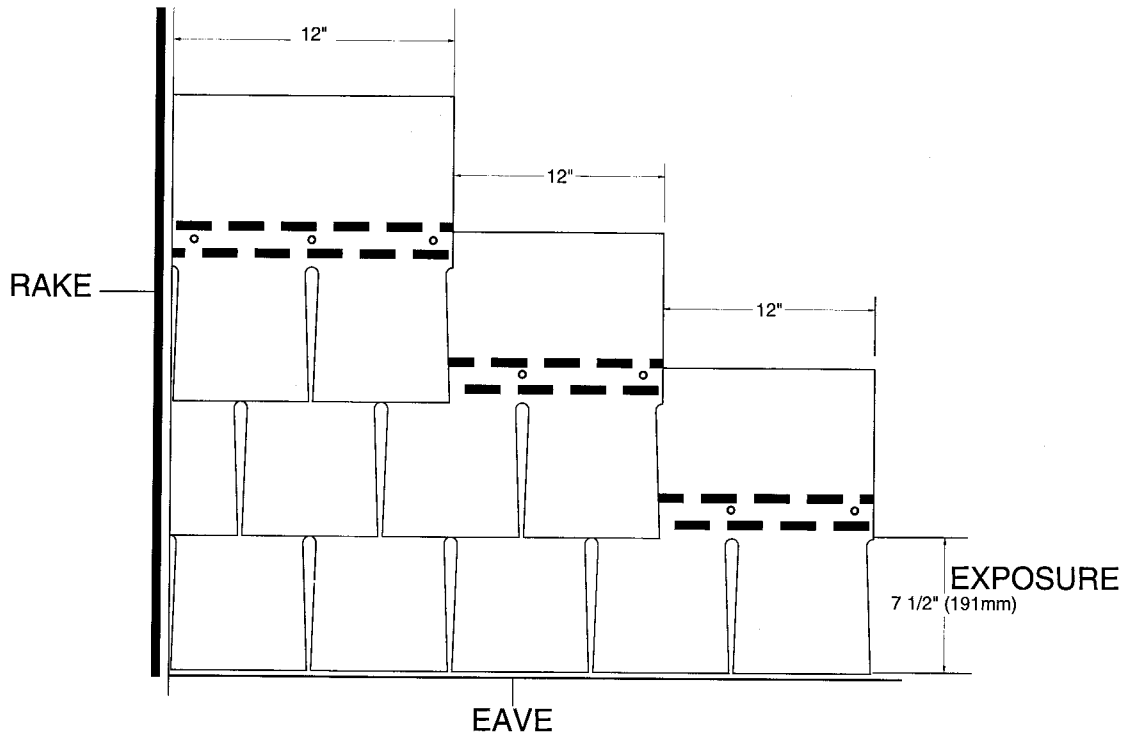
- 5.1 Shingles shall be labeled with the Miami-Dade Logo or the wording "Miami-Dade County Product Control Approved"

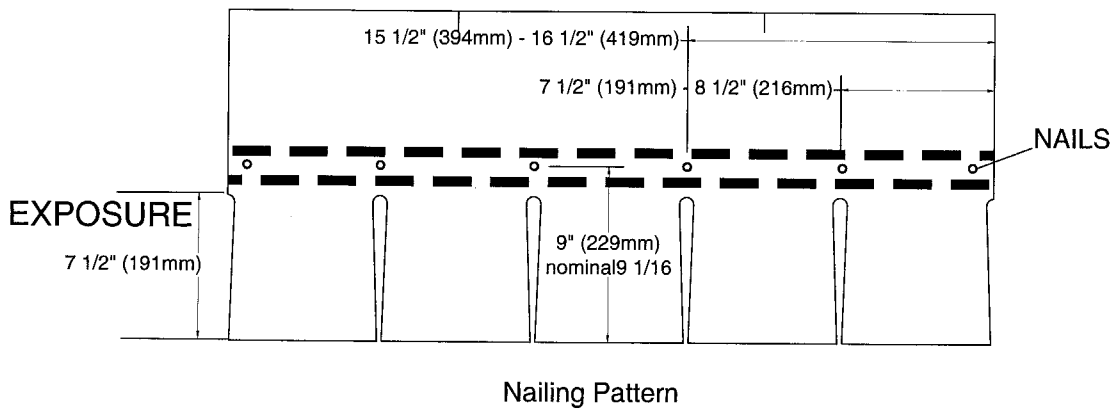
- 6.1 Application for building permit shall be accompanied by copies of the following:
